Contract Amendment – Furniture Procurement Services: KBM Office Equipment Inc. (\$250,000)

# **Subject:**

Authorization to negotiate and enter into a contract amendment in an amount not to exceed \$250,000, with KBM Office Equipment Inc. (KBM-Hogue) for the procurement and installation of office, conference room, shared space, and other ancillary furniture to accommodate hybrid work at the Bay Area Metro Center (BAMC.

# **Background:**

After a competitive procurement, the Authority authorized a 10-year contract with an option to extend for two additional five-year periods with KBM-Hogue on June 25, 2014, for an amount not to exceed \$500,000 for Phase I professional services costs related to the design of new office furniture for the agency offices in the base building build-out. The contract was amended on May 15, 2015, September 1, 2015, June 5, 2017, September 1, 2019, June 28, 2023, and August 14, 2023, for a total amount not to exceed \$6,800,000 for the acquisition, delivery, and installation of furniture in offices and previously un-programmed spaces, conference rooms and public spaces at 375 Beale Street.

The proposed amendment would add an additional \$250,000 for design, procurement, and installation of office, conference room, shared space, and other ancillary furniture, including but not limited to in the Claremont Conference room – adjacent to the Board room - to update spaces and improve overall functionality in the hybrid work environment.

Funds for this contract amendment are included in the FY 2023/24 Building Improvement Fund – Capital Budget.

KBM-Hogue is not a small business enterprise or a disadvantaged business enterprise.

Staff recommends that the Authority authorize the Executive Director to negotiate and enter into a contract amendment with KBM-Hogue in an amount not to exceed \$250,000 for the procurement and installation of office, conference room, shared space, and other ancillary furniture to accommodate hybrid work at BAMC located at 375 Beale Street, San Francisco, for a new total contract amount not to exceed \$7,050,000.
