Consultant Bench: 2023 Project/Program Management and Strategic Advisor Support

Services – Cycle 1

Subject:

Request for approval of a pre-qualified Bench of consultants to provide as-needed project/program management and strategic advisor support services. The term of the Bench shall be until June 30, 2027, with an option to extend for an additional two (2) years.

Background:

On August 7, 2023, MTC issued a Request for Qualifications (RFQ) for the 2023

Project/Program Management and Strategic Advisor Support Services – Cycle 1 ("Bench"),
inviting firms to submit Statements of Qualifications ("SOQ"). The Bench would establish a prequalified list of consultants to provide project/program management and strategic advisory
support to MTC for any phase of a project. Email notification of the opportunity was sent to over
4,330 individuals and firms. Staff hosted a virtual pre-proposal conference on August 17, 2023.
Eighty-six (86) individuals attended the conference. Records indicate that 218 individuals or
firms downloaded RFQ-related documents. On the closing date of September 5, 2023, MTC
received SOQs from 28 firms. All firms met the minimum qualifications.

An evaluation panel composed of staff from MTC reviewed the applicants based upon the following evaluation criteria, with relative weights indicated in percentages: 1) Qualifications and Team Experience (60%); 2) Reasonableness of Rates (25%); and, 3) Presentation (15%). The firms the evaluation panel recommends for inclusion on the Bench are identified under the column "Placed on Bench" in Attachment A. All recommended firms demonstrated expertise in managing transportation and environmental programs and projects. Firms recommended for the Bench also demonstrated a thorough understanding of the Bay Area's transportation, land use, and environmental landscape. Firms that are not recommended for inclusion on the Bench are identified under the column "Not Placed on Bench" in Attachment A. Firms approved for the Bench will be eligible for work throughout the approved term of the Bench. Selection for entry into a contract with one of the pre-qualified consultants may take place by direct selection or via

a mini-procurement, pursuant to MTC's Third-Party Contracting Policies and Procedures. Contract periods of performance and amounts will be determined on a per-contract basis based on the project solicited to the Bench. Staff will return to the Committee for authorization of any contracts exceeding the Executive Director's signature Authority. Cooperative use language included in the RFQ allows other public entities to utilize firms on the Bench for their own projects and programs. Attachment B provides the DBE/SBE status of the prime and subcontractor firms recommended for the Bench.

Issues:

Recommendations:

Staff recommends that the Regional Network Management Committee approve the pre-qualified consultants identified in this memorandum for the 2023 Project/Program Management and Strategic Advisor Support Services Bench to provide project/program management and strategic advisory services on an as-needed basis, for a period through June 30, 2027, with an option to extend through June 30, 2029.
