Contract Amendment – Regional Mapping Data Services: Interline Technologies LLC
(\$808,825)

Subject:

Authorization to negotiate and enter into a contract amendment with Interline Technologies LLC in an amount not to exceed \$808,825 for Regional Mapping Data Services.

Background:

In 2022, MTC completed a competitive procurement process to select a consultant to plan, design, and develop a new Regional Mapping Data Services (RMDS) system in coordination with the Regional Mapping and Wayfinding Project.

In December 2022, MTC’s Operations Committee approved the selection of Interline Technologies LLC and authorized MTC to enter into an agreement with Interline Technologies LLC, in the amount not to exceed \$971,175 to provide software development and maintenance services for the RMDS system. In May 2023, the Executive Director authorized a contract amendment in an amount not to exceed \$20,000 to conduct stakeholder workshops in person, instead of the originally scoped virtual workshops, and to add the expertise of a specialized workshop facilitator.

The goal of this RMDS project is to develop, operate, and maintain a new mapping data services system that will host, maintain, and share transportation data for the nine-county San Francisco Bay Area region. This system will provide the underlying data platform for the Regional Mapping and Wayfinding Project to deliver mapping products with specific design attributes defined in the Regional Mapping and Wayfinding System Design Standards. It will utilize open sourced OpenStreetMap (OSM) base layers to facilitate enhanced mapping.

The RMDS original scope of work was written to use existing OSM data with the current regional transit data provided by the 511 SF Bay system and to assess additional Mapping and Wayfinding needs. Through RMDS stakeholder workshops and the needs assessment process, the scope was amended and refined, including the need for an OSM data review and improvement in and around Bay Area transit stations. If approved, funds for this amendment will be utilized to develop an

OSM data management system. Funds will also be used to collect (via in-person visits to stations) and deliver enhancements to the existing OSM and regional transit data, which are needed to support the Regional Mapping and Wayfinding project, and thereby provide more comprehensive transit information for the region.

Interline Technologies is a Small Business Enterprise. Interline Technologies has five subcontractors for a portion of the work under the contract, including DCR Design LLC and Garnet Consulting LLC that are certified Disadvantaged Business Enterprise firms. Attachment A includes summary of Interline Technologies and its project teams' small business and disadvantaged business enterprise status.


